The Town of Thayne provides water, and sewer services to the residents of Thayne. The minimum or base charge for Thayne residents is \$ 34.75 per month for Water (rate varies per tap size) and \$ 30.25 for Sewer. The Town of Thayne reads water meters once per month and you are charged additional water fees for water used over 30,000 Gallons at an additional charge of \$1.50 per 1,000 gallons. **PLEASE NOTE: SEWER CHARGES WILL CONTINUE TO ACCRUE EVEN IF WATER HAS BEEN TURNED OFF. WATER IS CHARGED A \$15.00 VACATION RATE MONTHLY FEE WHEN SHUT OFF. THERE IS A WATER TURN ON & TURN OFF FEE OF \$35.00.**
