Approval of November 20, 2019 Council Meeting Minutes and the Adoption of the Agenda as finalized.

Mayor Simpson opened the Public Meeting at 6:01pm for the annexations of The Meadows at Star Valley and the Sewer Property.

- The Meadows at Star Valley Annexation-Marlow Scherbel of Surveyor Scherbel presented a master plan on behalf of Douglas Child. Marlow stated that the lots are currently smaller that the required 15,000 sq. ft. but the average lot size does meet the requirement and suggested to the Council that they approve the master plan as a Planned Unit Development for the Town of Thayne. The Town Council stated that they liked where the development was headed and that the Town would look into a Planned Unit Development.
- Mayor Simpson asked for questions or comments on the Sewer Property Annexation, none were given. The public meeting was closed at 6:41pm.

- Thayne Storage Tank Project
 - All work is now complete on the new water tank and the final payment to the contractor will be on January 7, 2020. There were some changes made to the SCADA system that all went well. Robert Hood stated that Western Municipal Construction of Wyoming has agreed to reimburse the Town of Thayne \$5,000 for going over the allowed construction time that caused extra engineering fees.
- North Waterline Project
 - All work is now complete on the North Waterline Project and the final payment to the contractor will be on January 7, 2020. There are a few items that will need to be cleaned up next spring under warranty work.
- TAP Projects
 - Will get ready to bid the Pathway Lighting Project and the Wright and Van Noy Sidewalk Project in the spring.

- Community Center Parking Lot Improvements
 - The grant application will be reviewed at the January 17th 2020 SLIB meeting in Cheyenne.
- GIS-Geographical Information System
 - Mayor Simpson stated that he would like to update our water and sewer system and use technology that is available to us.

- Councilman Heward stated that he had a public comment and question for Councilman Wicks. Heward referenced an email that was sent from Councilman Wicks to Mayor Simpson regarding the color of the new water tank and "backroom meetings" that were being held. Heward stated his opinion that he thought both questions were inappropriate; that there are never any backroom meetings held, all meetings including those regarding the new water tank were public knowledge. Heward also stated that bringing ones family or children into Town business is inappropriate and should never happen.
