#### Public Meeting for Thayne North Waterline Project Open at 5:32pm

The purpose for this public meeting is to receive any comments related to the application that the Town of Thayne recently submitted to SLIB to increase the funding on the Thayne North Waterline Project by \$176,000. The scope of the project is to replace the waterline that goes norther of Town on the east side of Hwy 89 and also replace the waterline to the sewer lagoons. Due to the future Highway widening, the waterline alignment needed to be modified adding additional footage and complexity to the project and the Town also needed to add the Heap Drive waterline to the project. The Town of Thayne has requested an additional \$176,000 from the State to cover the cost of these additions. The loan amount will be 25% of the project costs at \$124,000 with a 2.5% interest rate for 20 years. The estimated annual payment is \$12,445 if the entire budget is used. The Town of Thayne doesn't anticipate a rate increase with the North Waterline Project. Mayor Lainhart then asked for comments from the public. Mr. Lawton, a Town of Thayne citizen asked about looping the new waterline down Roberts street to help with the current pressure issue. Lainhart stated that the new water storage tank project the Town is starting in the spring should be the solution to the pressure concerns on Roberts Street. The Town of Thayne did not receive any written comments from the public.

#### **Thayne Ambulance Service**

 Lesli Dana asked the Council for an extension on the Thayne Ambulance Service budget project. Dana stated that with recent events she has not been able to complete the project. Lesli also apologized to the Council and to Clerk Hillstead for not submitting December's meeting minutes yet and stated that she would get them done as soon as possible.

#### DeCoria, Maichel & Teague-David DeCoria

Mr. DeCoria presented the Town of Thayne's 2016-2017 audit report. DeCoria stated
that the Town received an unqualified opinion and the Town's funds are correctly stated
in the financial statements. David congratulated the Town on a very successful year.
Copies of the 2016-2017 audit report are available at the Thayne Town Hall.

## **Maverick Building Permit**

 Mayor Lainhart asked for comments or concerns regarding the building permit that Maverick has submitted. Councilman Wicks asked if Maverick's construction would have any effect on the Moser Ave. water project. These projects will be on opposite sides of the road and will have no effect on one another.

with the general maintenance needs while Cliff is gone. The Council decided that the
Town would ask the temporary employees for assistance and would also hire
professionals for specific jobs as needed.

- Councilman Heward notified the Council of the broken waterline that has since been repaired in El Jean. Heward also mentioned that the transformer needs to be replaced at the sewer lagoon.
- Recreation Report
  - The first year of women's volleyball is complete, the season went great. Basketball registration has closed and teams are being formed. The Ski club is looking for 6 to 7 more kids to sign up to allow the Town to get a second bus.
- Councilman Heward stated that the Council needs to start ear marking specific funds at the end of the fiscal year so that those funds will roll-over to the next year and not all fall back into the general fund. Clerk Hillstead is working with Caselle to learn how to correctly do this.
