Thayne Ambulance Service

- Sherri Merritt with the Thayne Ambulance Service gave an update and the current service roster to the Town Council. Merritt stated that she would like to publicly thank the community members for their generous donations throughout the year. Those donations have allowed the service to purchase 16 adult and 16 pediatric CPR mannequins for training.
- The current board members are Delsa Bird: Captain, Kaitlyn Nield: Co Captain, Tonya Taylor: Secretary, Sherri Merritt: Training Officer and Shanna Bird: Sargent of Arms.

Motion to ratify the two new board members on their specific positions.

Sherri also stated that Mallory and Alesia Winters have retired from the service and that
they will be greatly missed. The board members have decided to allow the Winter's to
remain on the retirement roster but they will have to pay their own monthly fee for a
total of \$180 per year.

DeCoria and Company Audit Report

 Dave DeCoria presented an overview of the 2018/2019 Town of Thayne audit. DeCoria stated that the Town received two findings but overall is in good standing.

Sunrise Engineering

- TAP Projects
 - Robert stated that he and Clerk Hillstead had a telephone conference with David from WYDOT regarding the current projects.
 - The Pathway Lighting Project is being treated like a brand new project and we have to start from step one with a consultant selection for the project engineer.
 - Sunrise Engineering has found a sub consultant to perform the historical evaluation on the Community Center. A contract amendment is needed with Sunrise Engineering before the evaluation can be completed and needs to be approved by WYDOT. Robert is hopeful to bid this project with the Community Center Parking Lot Project.
- GIS-Geographical Information System
 - The contract has been signed but Sunrise Engineering will wait until the snow melts to get the remaining information needed to complete the project.

Representative Evan Simpson

- Representative Simpson stated that he wanted to come and gain input from the Town Council. Simpson mentioned that this year is a budget year and the revenue is way down and in two years from now there will potently be no savings left.
- WYDOT-HWY 89 update: the Etna to Alpine portion of the road is set to begin in the fall of 2020.
- Simpson commented on Resolution 01-01-2020 SF0159 that was before the Town
 Council regarding coal. This resolution is showing the Town's support of coal and how
 there will be a significant financial impact if the coal mine is shut down. Councilmember
 Lee Schwab stated that he would like more time to look into SF0159 before a vote is
 cast.
- Mayor Simpson mentioned three things to Representative Simpson; 1. The Town of
 Thayne is in favor of the direct distribution tax of 105 million and would like to see that
 stay the same, 2. The Town of Thayne would like to see the Local Option Use and Sales
 Tax come in effect which would add 1% sales tax and that revenue would stay in the
 local town and 3. The Town of Thayne is very much opposed to the Municipal Property
 Tax.

this proposed development. Woolley would not like to take the roads over as town

that the Town of Thayne would not accept the roads in the Meadows Subdivision until
such roads were up to town code and standards.
