Shriners Committee-Toby Merritt

Toby Merritt stated that he was in attendance to verify that the use of the Thayne Community Center was still approved for the Shriners Banquet on February 13th 2021. Councilman Woolley mentioned to the Town Council that he was approached by Jacknife Beef wanting to purchase the Snowdays snowcat. The snowcat is old and has been sitting without use since Snowdays has been cancelled. Woolley stated that he accepted \$2,000 for the snowcat and has delivered the check to the town hall and released the machine. Woolley stated that he would like to see those funds used for equipment in the future.

Mayor Simpson

Town Updates

Mayor Simpson mentioned that the Lincoln County Recreation Grant is due by the end of February. Councilman Heward added that he will get stated on the grant.

Mayor Simpson updated the Town Council on the purchase of lot #3 in the Thayne Business Park by Bart Merritt. Simpson stated the he had already completed a purchase agreement extension to the January 31, 2021. Another extension will possibly be needed as it is taking Bart Merritt longer to secure his funding. Mr. Merritt will pay for the extension if needed.

Trevor Petty with Valley Tech suggested to Clerk Hillstead that she start looking into getting a new hard drive since there has been increasing issues with the current computer.

Motion to approve up to \$1,300.00 + tax for a new clerk computer

Motion- Councilman Heward Seconded- Councilwoman Passey Motion Carried Mayor Simpson ask the Town Councilmembers if they had a chance to look over the proposed changes on Title 10 of the Thayne Municipal Code that was handed out at the December meeting and if there were any questions, comments or concerns. Simpson added that currently there is no zone where apartment complexes are allowed. The commercial zone was originally designed for commercial businesses and apartments were not wanted in prime commercial zones. Simpson proposed the following zones: AR-1 single family, AR-2 single family / twin homes, AR-3 which would allow apartment complexes and removing the C-2 heavy commercial zone.

Phil Tippetts – DeCoria and Company 2019/2020 Audit Report

Phil Tippetts called the Town Council via facetime to give the 2019/2020 audit report. Phil stated that the Town of Thayne received an unmodified opinion from DeCoria and Company. An unmodified opinion is the highest rating that the company can give. The only finding the Town of Thayne received was due to the deficiency in internal controls and segregation of duties due to the Town's small staffing size.

Mayor Simpson

Mayor Simpson resumed the discussion on Title 10 of the Thayne Municipal Code. Councilman Heward suggested adding in terminology in the C-1 Commercial zone to include apartment complexes per Council approval. Mayor Simpson added that wording could cause the Town risk of showing favoritism to one over another. Mayor Simpson expressed his concern that he doesn't want to see the last of the commercial lots for a business in the Town of Thayne taken by an apartment complex. Councilman Heward suggested that the Town look into the leagalities about not allowing apartment complexes on Main Street (US 89) and also look into not allowing main floor apartments on Main Street. If the Town cannot legally enforce then the Council will look into other options. Mayor Simpson stated that he will work with Town Attorney Kevin Voyles and will report at the next meeting.

Mayor Simpson gave a WyoStar II update and suggested waiting another few months before money was moved around again.
